**Why I am a candidate to IPA' Board of Representatives?**

I am Gleda Brandão Araujo, full member of the **Mato Grosso do Sul Psychoanalytical Society ("SPMS")** and of the **Rio de Janeiro Psychoanalytical Society ("SPRJ")** since 1999, and training analyst in the SPMS Training Institute since 2001.

My institutional trajectory began back in 1989, when my society (SPMS) was still a SPRJ' nucleus. Since then I have worked on many posts, first in my Society, then in the Brazilian Psychoanalytical Federation and last at FEPAL, in management, institutional, scientific and in education. I had also the opportunity to take part in some IPA's committees.

My trajectory in different institutions has broadened my view of psychoanalysis and its insertion in culture and society and of the role of IPA's support and investment in its component societies, as it has also enabled me to develop a broader vision on the nuances, challenges and needs of Brazilian and Latin-American societies.

Representing Latin America in IPA's Board means, over all, acting as a bridge between IPA, its members and affiliated societies. It means playing a truly democratic role: listening, and taking all demands, ideas and needs brought by Latin-American societies and its members to be discussed in a broader forum.

**I think in the following issues for my work:**

Strengthening of societies and regional federations through reflection and action before the challenges we face in our continent. Broadening of dialogue between IPA and societies, with mechanisms that allow societies to reach out to IPA with their issues and challenges and with more scientific interchange between IPA's regions.

Equally important are those actions that help struggling societies to settle their conflicts, through counseling and mediation to offer the society the tools to settle their disputes.

Expand and strength actions such as those led by IPA's professional committee, which have helped analysts that migrated or that plan to migrate.

Investing in the expansion and consolidation of quality transfer of psychoanalysis, for it is the key to face constant threats of regulation of psychoanalysis. Psychoanalysis can only be strong, if it represents a strong idea (Freud).

Amplify and intensify actions for beyond the boundaries of our institutions, as we have so much to add to education, health, law and social area. The possibilities are endless.

Promote a training of excellence in the clinic with children and adolescents, groups, and with older adults, taking into account not only the therapeutic aspect, but also the *preventive value* in the defense of the most vulnerable part of the population.

Carry on with the different models of Working Parties which promote a reliable tool for the study and the investigation of the psychoanalytic treatment.

Favor the opening to the social and scientific disciplines that cross-link with the clinical situations that are entrusted on us, as a contribution to the understanding of our problems, knowing nonetheless that in no way can they replace or overshadow the value of Psychoanalysis.

Lending a major and effective attention to the serious payment difficulties of the countries of our region due to the economic crisis.

Work for the inclusion of the Portuguese language as an official language of IPA, as a language of same importance as Spanish, such as is done in all our Latin American congresses.

Give a strong support to COWAP's work, as Virginia Ungar has already been doing, as developed in the important conferences, in particular the latest one in Lima, and facing the meetings of the 2019 IPA Congress in London.

Uphold the leadership of the IPA in all the mentioned areas, through an organization that takes into consideration the problems of the XXIst century, with the scientific and ethical involvement that were the ideas of the founder of Psychoanalysis, attending the needs and initiatives of our region, consistent with the projects of the international psychoanalysis.

**Daniel Delouya (Brazilian Psychoanalytic Society of São Paulo)**

I am Daniel Delouya, 60 years old, full member, since 2007, of Brazilian Psychoanalytical Society of São Paulo (SBPSP), where I am also a training analyst. My training began in 1999 and I became an IPA member in 2004.

Long before I became an associate member of SBPSP, I was already engaged in scientific, educational as well as in other institutional activities within other psychanalytic institutions: as a member of the editorial board of *Percurso* (a psychoanalytic Journal), as a chief editor of *Psyche* Journal, as a fellow researcher in psychoanalytic field, as a member and professor of graduate studies, as well as a director of psychanalytic institute of São Marcos University (2002-2007). As soon as I became a full member of SBPSP, I initiated my activities of teaching, supervising and analyzing candidates. I was elected a member of the education committee, and soon also involved in the Cultural and Community committees of SBPSP.

During the last seven years I have been very much involved in the Brazilian Psychoanalytic Federation, FEBRAPSI, where I occupied successively the following positions: Scientific secretary (2011-3), Scientific director (2013-5) and President (2015-2017).

Over time, I discovered that my long trajectory within the psychoanalytic community sought to detect which areas could be explored by the psychoanalytic instrument. These concerned not only the deepening of clinical practice and all its related technical and theoretical aspects, but also the implication of the analyst, his method and his means of comprehension, approaching and acting in the various fields of culture and community in its social and political dimensions.

Therefore, I think that in the contribution to the Board, classical and perennial questions concerning analytic formation require the representative to have a more comprehensive scientific culture of the schools and currents of psychoanalysis in order to situate his position and dialogue with the other representatives of other societies and regions of the world. In addition, the IPA should, following the founder of psychoanalysis, be involved and position itself, based on the psychoanalytical method, on the contemporary issues and dilemmas of the field of art and knowledge, but especially those related to the community, and its current developments : in relation to areas of national and race conflicts, wars, migrations, social and race discrimination, abusive political regimes, among other topics that concern new forms of existence and self expression in culture, such as the diversity of sexual identities, ways of living sexuality, as well as family, work etc.

The scientific exchange of psychoanalytic practice and the broader exercise of psychoanalysis in relation to culture and contemporaneity may reinforce, along with IPA, the growth of psychoanalysis and its full exercise and responsibility in relation to civilization.

**Jorge Kantor (Peru Psychoanalytic Society)**

Dear colleagues from the Latin American region:

I am writing to request your support for my nomination for a second and final term on the IPA Board in the elections for the 2019/20 period.

In this vote, around half of the 21 members of the Board will be ending their second term. In our case, four of the seven members of the Latin American representation will necessarily be newcomers, taking into account that Abel Fainstein, Sergio Lewkowicz, Álvaro Nim and Claudio Rossi are ending their second term.

For this reason, I consider it vital to maintain a degree of continuity in our representation so that we can better consolidate the initiatives, decisions and matters outstanding of the current administration.

A second term involves an even greater involvement in the tasks of the Board, given the greater experience and understanding of the IPA's structure and functioning, acquired during the phase currently underway. The IPA manages an annual current budget of around \$3 million and oversees the functioning of more than 50 committees with more than 600 members.

To avoid any conflict of interest, representatives are restricted from participating in these committees, with the exception of a small number of committees requiring that they be made up of Board Representatives from the three regions, together with other regional representatives.

I represent our region in the core Budget and Finance Committee (BFC), together with the treasurer and five colleagues from the three regions. Participating in the BFC has enabled me to clearly understand the IPA's organization and processes.

I can affirm that I have contributed to the organization and general planning, with particular attention to the needs and initiatives of our region. To cite concrete examples: regarding the payment difficulties of some of our countries, hit by economic and social crises; the ongoing proposal for an original publishing project; and the request for funds for the translation of an event into Portuguese, it not yet being one of the official IPA languages.

In this regard, during this second term I would like to advocate for Portuguese potentially being considered an official IPA language.

At the plenary Board meetings, the Latin American delegation has maintained a united position in response to controversial issues that have emerged. We have supported a productive schedule of projects in international psychoanalysis, without losing sight of the issues of our region, the primary reason for our participation in the IPA.

The next two years will be the last for the Latin American administration presided over by Virginia Ungar; accordingly, it is to be expected that we will see an evolution in the initiatives taken in the first stage of her administration. This period will be especially productive in terms of results and outcomes. Once again, it is essential that a part of the Latin American delegation continue the work previously undertaken on the Board.

I would like to take this opportunity to renew my commitment to representing Latin America with a regional agenda consistent with global interests.

I hope to once again count on your vote.

**Anette Blaya Luz (Porto Alegre Psychoanalytical Society)**

***Towards a strong and modern psychoanalysis***

I am Anette Blaya Luz, 65 years old, a full member, since 2005, of the Psychoanalytic Society of Porto Alegre, SPPA, where I am also a training analyst. My training began in 1988. I became an IPA member in 1995.

Institutional activities were always significant and pleasurable for me. Much of the scientific exchange and socializing with colleagues happen within our societies and institutes. This enhances the development of psychoanalytic theory and practice, besides offering opportunity for productive and affective relationship amongst ourselves.

During the last ten years I have been very much involved In the Brazilian Psychoanalytic Federation, Febrapsi, where I have occupied different positions. Presently I am the President, position that I will keep until November/2019.

My psychiatric training took place in Canada, where I lived for four years. I speak English, Spanish and Portuguese fluently.

I thought my contribution to IPA Board in four main axes.

First: to work to reinforce the psychoanalytic practice. Right there in the consulting room our practice develops, and creativity may occur. The transference relationship testifies the value of the analytical method and it's understanding contributes to lessen human suffering and enhance mental health. I believe IPA must keep a constant dialogue with culture, as to guarantee that Psychoanalysis be in touch with new paradigms, such as new manifestations of human emotional suffering, the life in cyberspace, new forms of sexuality and family organizations. Our practice must adjust to these, without jeopardizing technical standards.

Second: refers to the training of new analysts, source of vitality and continuity. Transmission of good practices, which are faithful to Freud's concepts while allow for technical developments consonants with cultural evolution of societies is a challenge to face and represents a strong and modern psychoanalysis. This requires solid, consistent and airy training. Also, the stimulus to writing and publishing work by our members and candidates. Latin America has a lot to contribute Internationally. We have a plural and creative psychoanalysis, that deserves being published, not only in Portuguese or Spanish.

Third: concerns the relationship with community and culture. The possibility of an extramural psychoanalysis brings populations benefits that our tradition enjoys. Work with

educational institutions and other areas of culture enriches psychoanalyses, while contributes to its expansion and human development. We have improved in this regard, but our influence on culture can be even more meaningful. We have a lot to offer and a lot to learn from this interaction.

Fourth: institutional activities. Investments in research and the scientific exchange within institutions of different latitudes promotes a productive, creative and collaborative psychoanalysis. The encouragement of candidates to take part in their institutes is something I believe important.

An approach through these axes could strengthen Latin American Psychoanalysis. The experience I have accumulated in these years of clinic, editorial work, participating in scientific and administrative activities through positions I have occupied, enables me and confer me confidence to represent Latin America in the central core of the IPA.

**Aurora Polto (Uruguayan Psychoanalytical Association)**

I feel honoured to have been nominated by the Uruguayan Association's Board (2016-2018) as a candidate for the post of Latin American Representative on the IPA Board. I believe that the relevance and specificity of the transmission and dissemination of psychoanalysis in the world calls for commitment, dedication and enthusiasm proportionate to the magnitude of the task.

Becoming a psychoanalyst is a detailed and complex process, which dialectically articulates the unconscious element of our subjectivity with the other, as well as with the institutions we form (FEPAL and IPA), which enrich our heritage by providing diverse cultural viewpoints. Institutional frameworks for training and ongoing reflection between psychoanalysts are vital to our task.

The experiences of scientific exchange and plural debate in the psychoanalytic community through local, regional and international congresses, as well as the contribution of the current working arrangement of the Working Parties, and the International New Groups (ING) worldwide, are invaluable opportunities for the dissemination of psychoanalysis and to access, problematize and alleviate human suffering – whether individual, socio-political or civilizational.

Latin American representation in decision-making and participation in the different IPA Committees is a substantial task that calls for a balance between experience and generational renewal. The Latin American Institute of Psychoanalysis (ILAP) has consolidated a significant contribution in those countries where there are no IPA institutions. Of particular importance, in my view, are the scientific didactic exchanges on a regional and international level (CAPSA) that advance current psychoanalytic thought in other IPA regions. The work undertaken with the younger generations in organizations for training analysts (OCAL and IPSO) should be prioritized, with emphasis on the training of new psychoanalysts and their participation in the ongoing institutional life of the IPA.

Respect for pluralism and the singularity of contemporary psychoanalysis I value as a cornerstone. And in this regard, the Uruguayan model of analyst training still stands as one of the three IPA models as a valuable contribution in the development of new institutions and the training of its analysts.

**Areas of action:**

- Strengthening and promoting plural forms of scientific-didactic exchange in the local, regional and international psychoanalytic community.

- Promoting the importance of Training Institutes in their role of psychoanalytic transmission with rigour in their specificity, maintaining the ethical standards that define them.
- Underscoring the work of the International New Groups (ING) in the process of being formed, and those yet to be formed, in the different IPA regions, to continue the dissemination of contemporary psychoanalysis.
- Supporting the translation of psychoanalytic publications in the main languages (e.g. the e-journal *Psychoanalysis.Today*) and encouraging the languages required by the expansion to new regions.
- Encouraging the transmission of regional and international scientific-didactic exchanges, conferences and debates via electronic fora, the IPA website and webinars.
- Stimulating the plurality of existing lines of research and those yet to be developed within the IPA.
- Advancing the emphasis given to the work of 'IPA in the Community' in different fields: education at various levels, health, and society and culture in its various expressions.

This experience allowed me to know even more closely the extraordinary theoretical - clinical vitality of Latin American psychoanalysis and to recognize the importance of inter-regional discourse and exchange. Diversity, respect for different traditions and pluralism should be the flag that represents us all throughout the IPA.

Ours is a time of political, social and economic upheaval, where violence against women and prejudice against immigrants risk becoming the norms. These trends must be recognized, understood and opposed. **Pablo Santander (Chilean Psychoanalytic Association)**

My nomination for re-election to the IPA Board involves the desire to continue providing the perspective of a small association such as the Chilean Psychoanalytic Association. I am a full member, teacher and training analyst within my association; I am nevertheless a young member. This period, in which I have participated as Latin American Representative to the IPA Board, has been a great learning experience for me, and one in which I have been able to support and take part in the guidelines of the current executive headed by Virginia Ungar, such as making an IPA for all, fostering greater proximity, and furthering participation and member involvement in the societies, as well as advancing the idea of the outreach of psychoanalysis to the community and to the wider culture.

My view of contributing on the Board is to support Latin American thought and its place in the IPA, to collaborate and support societies in conflict, as well as to maintain and foster good communication between the societies and the IPA.

In my years as a psychoanalyst I have had the opportunity to hold various positions internally and I believe that this has given me an important perspective on the requirements of societies and local modalities of functioning. I was responsible for founding the Social Phenomena Studies Committee in my Society, learning from the immense contribution psychoanalysis can make to the society in which we are immersed. This has enabled me to learn about social and group dynamics in their widest sense.

Within my society I have been interested by the correlation between psychoanalysis and literature, organising meetings and outreach activities on these topics. The issues of social contingency have also formed part of the areas of interest of my professional development, and as such I have published articles in psychoanalytic and political science journals both nationally and internationally. I recently published a book on the Chilean process of transition from dictatorship to democracy through the lens of psychoanalysis. Art is another area that I think can bring a further perspective to psychoanalysis, for which reason I have taught extension courses, and have published several articles on the subject. Lastly, the subject of clinical psychoanalysis emerges as an ongoing challenge, and an area of great interest to hear and exchange different viewpoints, and thus enrich our clinical practice, hand in hand with the evolution of the society in which we are immersed.

Psychoanalysis is a theory, a practice and a model of the mind that creates passion and fosters important developments; my interest is to collaborate actively to encourage this growth, by fostering discussion and mutual contribution, which is so vital.

- ✓ To continue to fulfil the link function between the Board and the Latin American Associations with the purpose of strengthening the relationship between the IPA and the Component Societies.
- ✓ Increase the participation in Universities to have a greater presence in degree and postgraduate courses. My work as a teacher and the four years (2013 -2017) spent as a Director of the M.A. Program in Family and Couple Therapy at the University Mental Health Institute of the Buenos Aires Psychoanalytical Association have enabled me to gain a greater insight into the relationship between Psychoanalysis and the University as an Institution.
- ✓ Continue promoting congresses that allow space to debate the challenges which arise in current clinical practice in small discussion groups.
- ✓ Promote the translation of scientific papers. This will foster interaction and will promote the development of psychoanalytical ideas.
- ✓ Support the development, training and research into the psychoanalysis of children and adolescents, together with the psychoanalytic study of families and couples. We need to acquire the tools to deal with the challenges that arise from the new ways in which family and couple bonds are constructed in the twenty-first century.

**Laura Verissimo de Posadas (Uruguayan Psychoanalytical Association)**

It would be an honor and a responsibility to represent my Latin American colleagues at the Board of the Association created by Freud, constituted by subjects in conflict moved by desire, confronted at all times for more than a century to the changes and turbulence of History.

IPA brings together psychoanalytic cultures as diverse as those in the north and south of the planet, and those in the east and west. I believe that the “demands of work” is a stimulating challenge in the fraternal exercise of disagreeing, and in the inevitable tensions this disagreement might bring. This unrest can be a source of new ideas and new answers to old debates, since we are united by the bond of fidelity to the Freudian legacy, setting a strong emphasis on the liberating and transforming action of Psychoanalysis.

This concept applies not only to our practice in the uniqueness of the encounter with each patient. What I mean is that the tools acquired through our personal analysis, and the sustained and critical study of supervised theory and practice should be used in mental health institutions. In this way we would intensify our presence there, and we would raise our voice when basic human rights are overwhelmed, considering the enormous scientific, cultural and technological changes that are under way.

- If I were elected I would commit myself in creating the best conditions in our Institutes, for young people in training to become analysts capable of sustaining the listening of the unprecedented in the transfer, which constitutes our specificity.
- At the same time, I would encourage the psychologists’ work in hospitals and institutions in charge of children and adolescents, contributing in this way to the creation of spaces of psycho-social rehabilitation where the psychoanalyst could work side by side with those who face the pain of uprooting, and the suffering resulting from violence and discrimination.
- I consider it necessary to deepen the discussions regarding the training models and their flexibility, taking into account the intra-institutional reflections on meta-psychological criteria, giving continuity to the efforts of the regional delegates that preceded us.
- No discipline is enriched without sustained research. This implies the support as well as the exploration of the models of research in psychoanalysis, and the evaluation of the results to avoid investing in unproductive inertias.
