Psychoanalytical training, being established by a transit through the "tripod", inexorably leads to questioning the efficacy of its standardization and its relationship with the transmission of psychoanalysis. It is the question of finding the adequate bond between the practice and that which is transmitted through the tripod. We thought of some major points and questions on the theme:

Is the interference of the psychoanalytical institution on training working as an obstacle or a facilitator?

Taking into account each one of the elements of the tripod, is it possible to regulate training, or is it a dynamic process, in constant transformation?

How does the institution interact in the intimate – in the unconscious, in the analyst / analysand or the supervisor / supervisee pair – generating symptomatic questions related to the unspoken?

How does one proceed so as to not deviate from the proper, private and singular of an analysis, towards a regulation of it?
